AN ORDINANCE ESTABLISHING AN APPROPRIATION
ORDINANCE FOR FISCAL YEAR ENDING DECEMBER 31, 2019
AND THE DECLARATION OF AN EMERGENCY

WHEREAS, an ordinances required to make appropriations for current expenses, other expenses and other expenditures of the Village of Pleasantville, State of Ohio, during the fiscal year ending December 31, 2019; and

WHEREAS, the ordinance needs to be in place by the year 2019 in order to meet said expenditures;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF
THE VILLAGE OF PLEASANTVILLE, FAIRFIELD COUNTY, OHIO,
THREE FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

Section 1: That the Council of the Village of Pleasantville, State of Ohio, hereby provides for the current expenses and other expenditures of the said Village of Pleasantville during the fiscal year ending December 31, 2019, the following sum be and is hereby set aside and appropriated for the purposes for which expenditures are to be for and during said fiscal year, as on the attached sheets:

Street Construction Fund	\$29,920.00
State Highway Fund	\$ 2,500.00
Parks & Recreation Fund (\$20,600.00 Transfers Out Included)	\$20,960.00
Park Fund	\$ 3,450.00
Police Fund	\$20,725.00
Permissive Motor Vehicle Fund	\$ 7,500.00
Community Center Fund	\$ 5,800.00
Water Operating Fund	\$114,010.00
Swimming Pool Fund	\$25,800.00
Water/Sewer Deposit Fund	\$ 3,000.00
Walnut Creek Sewer District Fund	\$227,000.00

Total of all appropriations: \$613,857.00

SECTION 2: For the balance of 2019, the appropriations set aside for each line item can be moved between line items within the same fund at the discretion of the Chief Fiscal Officer.


