



## **Food Truck/Food Vendor Application**

### **Requirements**

- Food Truck/Food Vendor set up between 8:00 am and 11:00 am on Saturday, August 24, 2024 or the day prior to the event with permission.
- Festival will provide space for truck.
- Trucks/Vendors are responsible for providing their own generators/electricity, unless preauthorization by the village if granted as there are limited spaces.
- Vendor is required to have booth area open and ready for sales at 11:00 am and must remain open until 10:00 pm.
- Vendor is required to remain open during the required time (11:00 am until 10:00 pm).
- Alcohol sales are prohibited.
- Festival will take place rain or shine.
- Application fees will not be refunded unless the festival is cancelled.
- Pass fire inspection (around 10am the day of the event) prior to opening.
- The festival reserves the right to limit sales of certain food items.
- Provide a list of menu items with payment for review.

### **Fees**

- \$100.00 fee for non electric and non water space, non-refundable.
- \$150.00 fee for electric and/or water space, which are limited and must be preauthorized by the village or festival board.
