

**ORDINANCE NUMBER 12-30-19-01**  
**ADOPTED December 30, 2019**

**AN ORDINANCE ESTABLISHING AN APPROPRIATIONS  
BUDGET FOR FISCAL YEAR 2020; ENDING DECEMBER 31, 2020  
AND THE DECLARATION OF AN EMERGENCY**

WHEREAS, an ordinance required to make appropriations for current expenses, other expenses and other expenditures of the Village of Pleasantville, State of Ohio, during the fiscal year 2020 ending December 31, 2020; and

WHEREAS, the ordinance needs to be in place by the year 2020 in order to meet said expenditures;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF  
THE VILLAGE OF PLEASANTVILLE, FAIRFIELD COUNTY, OHIO,  
THREE FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

**Section 1:** That the Council of the Village of Pleasantville, State of Ohio, hereby provides for the current expenses and other expenditures of the said Village of Pleasantville during the fiscal year 2020 ending December 31, 2020, the following sum be and is hereby set aside and appropriated for the purposes for which expenditures are to be for and during said fiscal year:

**SECTION 2:** For the balance of 2020, the appropriations set aside for each line item can be moved between line items within the same fund at the discretion of the Fiscal Officer.

**SECTION 3:** For the reasons noted in the preamble, this ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety,

morals and welfare of the citizens of Pleasantville, Ohio. This ordinance shall become effective upon its passage by Council.
