CALL TO ORDER:

COUNTY BOARD OF REPRESENTATIVES REPORTS

<u>Regional Planning</u> – Councilwoman Dumolt shares there is nothing to report. <u>Board of Health ADHOC</u> – Councilwoman Dumolt has nothing to report but there will be a meeting on March 29th.

GRANT UPDATES:

Current/Awarded:

Nature Works Round 27 (2021-22) Otte Park Ball Diamond – bids were due January 11, 2023 @ 2:00pm. There were two bids received. One bid, Hickory Valley, was significantly over bid at \$87,172.00. Nash Construction submitted a bid of \$55,261.00. Councilman Williams made a motion to verbally accept Nash Construction's bid of \$55,261.00. Councilwoman Dumolt seconded.

President West – yes Councilman Mason – yes Councilwoman Dumolt – yes Councilman Williams – yes Councilman Pangborn – yes Councilman Munsey – yes Motion carried.

Councilman Williams also made a motion to approve Nash Construction to grade the outfield at Otte Park ball diamond for the additional amount of \$5,500.00. President West seconded the motion.

President West – yes Councilman Mason – yes Councilwoman Dumolt – yes Councilman Williams – yes Councilman Pangborn – yes Councilman Munsey – yes Motion carried.

...President West will take over as "manager" of this grant project as Mayor Henderson is a relative to Nash Construction's owner. All will still be included in communication.

ARPA Tank Maintenance. Awarded - \$650K by Fairfield County Commissioners. Meeting end of December with county regarding this. This will be a spring project.

CDBG Neighborhood Revitalization – Year 2022. Awarded \$692,600.00. Projects include: W. Columbus St. storm line replacement, Pearl St. storm line replacement, Hickenlooper repaving, Otte Park restrooms/concession stand, and Pleasantville Park baseball diamond improvements. \$100K also awarded from Fairfield County for Pleasantville Pool improvements using county CDBG funds. Bids will open up in January.

Applied for:

OPWC 2022. The Village applied for this grant November 4, 2022. Council applied for option 1 – installation of new storm lines in the alley behind Second Street at a cost of \$455,100. It was also chosen to pay an 11% local match. If awarded, this grant will allow for the Summit Street storm line to be fixed/replaced. This is about a \$400K project. Mayor Henderson sent via email, a map of this project details. The line will be routed behind Second Street.

VILLAGE MAINTENANCE REPORT:

Casey Ash reports the following November highlights:

- Two water shut offs due to breaks from the "hard freeze"
- Worked on Water Plant Paperwork and EPA paperwork
- Going through old Water Plant papers for disposal
- Water Plant repairs to waterline
- Repairs: 0 Meter replaced
 - 0 Curb box replacement
 - 0 Curb box relocated for construction
- Had a few water turn offs for water breaks on residential lines, with the last quick and hard freeze
- We took down the Christmas lights around town
- We cleaned up, tore down Christmas at the shop
- Repaired Drum Alley
- Repaired Water Plant parking lot
- Continuing GIS mapping

OLD BUSINESS:

Mayor Henderson reports that the house on S. Main St. has been completely torn down and there has been nothing but positive things being said by village residents.

NEW BUSINESS:

Ordinance 01-12-23-01 — An ordinance authorizing the Mayor and the Fiscal Officer to execute an agreement between the Village of Pleasantville and the Village of Baltimore for the provisions of police protection services. This contract increases from \$20K to \$23K due to fuel and increasing prices of things. Everything else in the contract is the same as prior. Councilman Mason made a motion to approve the ordinance and it was seconded by President West.

President West – yes Councilman Mason – yes Councilwoman Dumolt – yes Councilman Williams – yes Councilman Pangborn – yes Councilman Munsey – yes Motion carried.

2023 Music and Street Festival budget – Mayor Henderson provided council with an update of the festival budget and offered council to ask questions. None.

Resolution 01-12-23-01 — A resolution authorizing the Mayor and the Fiscal Officer to enter into an agreement with LDNL for entertainment at the Music and Street Festival. President West made a motion to approve the agreement being made. Second by Councilman Williams.

President West – yes Councilman Mason – yes Councilwoman Dumolt – yes Councilman Williams – yes Councilman Pangborn – yes Councilman Munsey – yes Motion carried.

Resolution 01-12-23-02 — A resolution adjusting the 2022 fiscal year budget. When the Village was audited, one of the findings indicated that there were not records being made of memo items. There has to be documentation showing "in and out" and this resolution adjustment "fixes" this finding. Councilman Mason made a motion to approve the resolution. President West second.

108 Pearl St. – Mayor Henderson reports that this address currently has 2 meters, 2 bills and only one shut off. He says that the ordinances and such should be looked at to see what can be done about this. Councilwoman Dumolt will take over and look into this. Mayor Henderson shares that there are several other properties in the village that are the same and will need to be looked into also.

<u>EPA Equipment Grant</u> – this form is giving Mayor permission to apply for this grant. The Mayor has been working with the maintenance department regarding items that could be purchased with this grant. If awarded (or not), can apply for the grant again in three years. The grant is for up to \$10K. A motion was made by Councilwoman Dumolt to give the mayor permission to apply for the grant. Second by Councilman Williams.

President West – yes Councilman Mason – yes Councilwoman Dumolt – yes Councilman Williams – yes Councilman Pangborn – yes Councilman Munsey – yes Motion carried.

COUNCIL MEMBER COMMENTS/CONCERNS:

Councilman Munsey reported that he had a meeting with Eastern Cottontail Solar as a private citizen.

Councilwoman Dumolt reports that there is a rise in crime in the village. Mayor Henderson shares that he has been approached by a citizen who would like to start the neighborhood watch program again. He has put this person in contact with Sheriff Lape. He says that council is not responsible for the neighborhood watch group.

MISCELLANEOUS ITEMS:

There is a "townhall" meeting regarding solar with area township trustees, local government officials – open to public – Wednesday, February 1st @ 7pm in the Community Center

Councilman Mason made a motion to adjourn, seconded by President West. Meeting adjourned at 7:43 pm.
