Floyd Stubbs of 109 Pearl St. interjected the meeting and asked council "why they do not like Pleasantville". He shares with council that he wants Pleasantville to stay small as it is. Mayor Henderson explains to Mr. Stubbs that council wants Pleasantville to grow with the times to help residents. Mr. Stubbs told council he received a letter saying he owed the Village money and "he will pay them the money he owes, but no one is taking his property". He said he wasn't aware of the RITA tax and he's lived at that property for years. Mayor Henderson explained to Mr. Stubbs that the RITA tax is collected from everyone that lives in the Village and is done so by RITA on behalf of the Village. The Village (office) does not have any information from RITA nor does the office send information out regarding RITA. Mr. Stubbs was advised to contact RITA directly to set up payment arrangements and for more information.
