### **FINANCE**

### **GRANT UPDATES:**

### Current/Awarded:

ARPA Funding. **\$825,000.00**. The village is waiting on paperwork from the contractor before work can begin. Village Engineers are working with the contractor to resolve. Work timeline is September to December for water tower maintenance.

CDBG Funding. \$100,000.00. In design phase for Pleasantville Pool Improvements.

NRG Funding. **\$818,000.00.** In design phase for W. Columbus St. storm line replacement, partial Pearl St. storm line replacement, Hickenlooper repaving, Otte Park restrooms/concession stand, and Pleasantville Park baseball diamond improvements.

*OPWC 2022.* \$450,000.00. In design phase installation of new storm lines in the right-of-way behind Second Street. Also working with property owner Mr. Ed Otte to obtain a minimum 20-foot easement and a minimum of 30-foot right-of-way for construction.

Ohio EPA Division of Drinking and Ground Water Grant. \$9,000.00 for the purchase of valve exerciser. Equipment received in October, reimbursement of funds to follow. COMPLETED

Fairfield County Foundation Grant. \$20,023.00. For the purchase of a new commercial gas range and hood at the Community Center. Village is responsible for labor which is \$20,100.00 in addition to the grant amount. Damaged parts and built wrong – are rebuilding – should be getting an update - it's being "rushed"

## **VILLAGE MAINTENANCE REPORT:**

Casey Ash reports the following November highlights:

#### **NEW BUSINESS:**

311 N. Main St. – A letter was sent to the homeowner asking what their next step was regarding the torn-up sidewalk in front of the property. The homeowner had a water leak and had to tear the sidewalk up. The letter from the Village indicated that the homeowner could fix it or the Village could fix it and assess their taxes. President Dumolt says council should give the homeowner more time to respond. Councilman Coleman says to reach back out to the homeowner. The Village will fill the area in with some type of granular for the interim and reach back out to the homeowner.

Discussion regarding handicapped parking in the village. These have to be updated yearly.

Ordinance 12-14-23-01 – An ordinance establishing a police department, authorizing personnel and fixing compensation and the declaration of an emergency. A motion to approve the ordinance to establish a Pleasantville Police Department was made by Councilman Coleman. Seconded by President Dumolt.

Ordinance 12-14-23-02 – An Ordinance Confirming the Mayor's Appointment of Chief of Police and the Declaration of an Emergency. A motion was made to confirm Mayor Henderson's appointment of Nicholas R. Garver to Chief of Pleasantville Police Department by Councilwoman Harrier. Seconded by President Dumolt.

President Dumolt –yes Councilman Mason – yes Councilman Pangborn – yes Councilwoman Harrier - yes Councilman Coleman - yes Motion carried.

Ordinance 12-14-23-03 – An Ordinance Establishing the Pleasantville Mayor's Court and the Declaration of an Emergency. Mayor Henderson does explain to council that the Ordinance does read that there is an allotted \$75,000 to set up Mayor's Court but after his research, it will not cost nearly this much. A motion was made approving the establishment of the Pleasantville Mayor's Court by Councilman Coleman. It was seconded by President Dumolt.

Mayor Henderson swears in Nicholas R. Garver as Chief of Pleasantville Police.

Mayor Henderson swears in Michael Shankle as Captain of Pleasantville Police.

Mayor Henderson swears in William Moore as Probation Officer and Mayor's Court Bailiff of Pleasantville Police.

Mayor Henderson swears in Heather Siders as Zoning and Property Maintenance Officer for Pleasantville Police.

Police Vehicle – Garver Asset Protection has a 2020 Ford Explorer "police" vehicle (set up for police) they are willing to sell or lease with no interest to the Village for use of the Pleasantville Police Department for \$24K. Councilman Coleman makes a motion to lease the 2020 Ford Explorer from Garver for \$24K. Second by Councilman Mason.

President Dumolt –yes Councilman Mason – yes Councilman Pangborn – yes Councilwoman Harrier - yes Councilman Coleman - yes Motion carried.

Mayor Henderson asked council for permission to attend training for Mayor's Court. Council granted permission.

Resolution 12-14-23-01 – Supplemental Appropriations to Budget – These appropriations include the following accounts: General Fund – professional and technical services, supplies and materials, salary legal; Street Fund – water-sewer; Park & Rec Fund – water-sewer park, water-sewer community center; Water Fund – sewer water plant, prof & tech service salt; WCSD Fund. A motion was made to approve the appropriations by Councilman Mason and seconded by President Dumolt.

President Dumolt –yes Councilman Mason – yes Councilman Pangborn – yes Councilwoman Harrier - yes Councilman Coleman - yes Motion carried.

Resolution 12-14-23-02 – Supplemental Appropriations to Budget – These appropriations include the following accounts: General Fund – Medicare, OPERS; Street Fund – Medicare, OPERS; Water Fund – Medicare, OPERS. A motion was made to approve the appropriations by Councilman Coleman and seconded by President Dumolt.
