AN ORDINANCE AUTHORIZING THE MAYOR AND/OR FISCAL OFFICER TO ENTER INTO AN AGREEMENT WITH ADVANCED BUSINESS COMMUNICATIONS, INC. (ABC, INC.) FOR EMAIL ADDRESSES FOR COUNCIL MEMBERS AND THE VILLAGE SOLICITOR AND THE DECLARATION OF AN EMERGENCY.


