AN ORDINANCE ESTABLISHING AN APPROPRIATIONS BUDGET FOR FISCAL YEAR 2024; ENDING DECEMBER 31, 2024 AND THE DECLARATION OF AN EMERGENCY

WHEREAS, an ordinance required to make appropriations for current expenses, other expenses and other expenditures of the Village of Pleasantville, State of Ohio, during the fiscal year 2024 ending December 31, 2024; and

WHEREAS, the ordinance needs to be in place by the year 2024 in order to meet said expenditures;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF PLEASANTVILLE, FAIRFIELD COUNTY, OHIO, THREE FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

Section 1: That the Council of the Village of Pleasantville, State of Ohio, hereby provides for the current expenses and other expenditures of the said Village of Pleasantville during the fiscal year 2024 ending December 31, 2024, the following sum be and is hereby set aside and appropriated for the purposes for which expenditures are to be for and during said fiscal year:
